**INTEREST OF AMICI<sup>1</sup>**

The American Center for Law and Justice (“ACLJ”) is an organization dedicated to the defense of constitutional liberties secured by law, including the defense of the sanctity of human life. ACLJ attorneys have appeared frequently before this Court as counsel for parties, *e.g.*, *Pleasant Grove City v. Sumnum*, 555 U.S. 460 (2009), or for amici, *e.g.*, *Whole Woman’s Health v. Hellerstedt*, 136 S. Ct. 2292 (2016), addressing a variety of issues.<sup>2</sup>

The American Academy of Medical Ethics (AAME) was founded to protect and promote the historic values that have provided the longstanding foundation for western medical care. The AAME is a dba of the Christian Medical & Dental Associations, which have over 19,000 members. The AAME comprises doctors, residents, medical students and associate healthcare professionals that subscribe to the traditional values of the Hippocratic Oath.

The American College of Pediatricians is a national nonprofit organization of pediatricians and other healthcare professionals seeking to ensure that all

children reach their optimal physical and emotional health and well-being.

The present amicus brief addresses the widely trumpeted, but surprisingly unsupported, misconception that abortion has been proven to be safe and routine, even safer than childbirth.

### SUMMARY OF ARGUMENT

This case addresses the constitutionality of abortion facility safety regulations. It is essential, therefore, that this Court understand that abortion, as currently practiced in the United States (and other developed nations), is often the occasion of medical mishaps, even serious injuries and deaths. In particular, the assertion that abortion is somehow safer than childbirth – an assertion echoed in this Court’s *Whole Woman’s Health* opinion – is an unsupported myth, contrary to sound, published medical evidence.

That last statement merits repetition: The claim that abortion is safer than childbirth is a *myth*, resting on demonstrably flawed premises and refuted by study after study.

### ARGUMENT

No one expects to see an ambulance pulling away from a dermatology or dental office. Yet ambulances are a not uncommon sight at abortion facilities. This sorry fact is just one of many that belie the abortion industry myth that abortion is safe and routine, even safer than childbirth. As demonstrated below, abortion in fact is a



hazardous procedure that all too often results in serious complications. Moreover, the common claim of abortion advocates that abortion is safer than childbirth is based upon incomplete data and flagrantly inapt comparisons. The published medical evidence strongly suggests that abortion is *more* dangerous, not less, than childbirth.

## I. ABORTION IS A POTENTIALLY HAZARDOUS PROCEDURE.

Petitioners June Medical Services *et al.* allege that “[l]egal abortion is one of the safest procedures in medical practice.” JA 20 (Am. Cplt. ¶ 20). This is false.

### A. Ambulance calls

People who visit a dentist, eye doctor, dermatologist, or ear/nose/throat specialist do not typically leave in an ambulance. Yet that is a frighteningly common occurrence at abortion facilities. Here is a partial list of *documented* incidents *from 2019 alone* in which an ambulance was called to transport a patient from an abortion facility:<sup>3</sup>

There is every reason to believe this list is just the tip of the iceberg. The news media do not, as a rule, report on medical emergencies at abortion facilities. Documentation of such occurrences therefore is almost

exclusively done by pro-life investigators or by demonstrators or sidewalk counselors who witness and report an incident.<sup>4</sup> Regarding the latter, documentation occurs only if (1) such persons are present outside abortion facilities, (2) such persons remain there long enough to be present when complications begin to arise (possibly many hours after the pregnant women entered the facilities), (3) such persons witness (or record) the incident, (4) such persons report the incident to some entity with a media platform, and (5) that entity publishes an account of the incident.<sup>5</sup> It is therefore logical to conclude that the incidents reported markedly understate the actual number of incidents in which abortion patients require emergency transport. *See, e.g.*, Letter of Batool Raza, Ass't General Counsel, Boston Public Health Comm'n (May 14, 2019) (responding to public records request with report of 10 ambulance calls to one particular abortion facility over one-year period);<sup>6</sup> *Planned Parenthood of Greater Tex. Surgical Health*

Moreover, not all serious complications in the aftermath of abortion manifest themselves quickly enough to result in ambulance transport from the abortion facility itself. A patient at a Maryland abortion facility, for example, was transported after the fact, by her family, to an emergency room; she subsequently died. *Operation Rescue*, “Carhart Patient Dead From Horrific 33-Week Abortion Injuries” (Feb. 8, 2013), <https://tinyurl.com/CarhartPtDth>. A woman who had an abortion at a Boston Planned Parenthood thereafter suffered “pronounced and constant” bleeding, which “included clots as large as a baseball,” made two trips to the ER, and ultimately learned that “about 3/4 of the fetus had been retained” in her womb. Cplt., Ex. A at 2-3, *Davis v. Mark*, No. 19-0119H (Suffolk Superior Ct. Jan. 14, 2019), <https://tinyurl.com/Davis-v-Mark-Cplt>. The long list of ambulance transfers, Appendix A, while plainly very incomplete, suggests the regularity of serious complications associated with abortion.

### **B. Maternal abortion deaths**

As noted, abortion can lead to the subsequent death of the woman. *See, e.g., The Pro-Choice Death List*, [www.safeandlegal.com/the-pro-choice-death-list/](http://www.safeandlegal.com/the-pro-choice-death-list/) (listing over 250 women who died from abortion).<sup>7</sup> Some examples of women who have died after abortions include:

## **II. THE CLAIM THAT ABORTION IS SAFER THAN CHILDBIRTH IS A MYTH.**

The common refrain that abortion is safer than childbirth is unsupported and almost certainly false. Indeed, the premises underlying this myth are embarrassingly inadequate, as demonstrated below. Perhaps for this reason, abortion apologists appear to have been quietly distancing themselves from the claim that abortion is safer than childbirth.

### **A. Relevance to abortion jurisprudence**

An understanding about the relative safety of abortion versus childbirth has been an important consideration in this Court’s abortion jurisprudence. Most notably, the trimester framework that was established in *Roe v. Wade*, 410 U.S. 113 (1973), and which governed abortion cases until *Planned Parenthood v. Casey*, 505 U.S. 833 (1992), hinged in part on the “factual assumption,” *City of Akron v. Akron Ctr. for Reprod. Health*, 462 U.S. 416, 430 n.12 (1983), that “until the end of the first trimester mortality in abortion may be less than mortality in normal childbirth.” *Roe*, 410 U.S. at 163. *See also id.* at 149 & n.44 (asserting that “[m]ortality rates for women undergoing early abortions, where the procedure is legal, appear to be as low or lower than the rates for normal childbirth”) (citing, *inter alia*, abortion mortality figures from U.S.

Department of Health, Education, and Welfare (HEW)). In *Whole Woman's Health v. Hellerstedt* (WWH), 136 S. Ct. 2292 (2016), this Court referred to material in the record asserting that “[n]ationwide, childbirth is 14 times more likely than abortion to result in death,” *id.* at 2315 (addressed *infra* §II(E)). And the district court in the present case also found that childbirth was more dangerous than abortion. Pet. App. 209a (finding No. 205) (also addressed *infra* §II(E)). As noted *infra* § II(C), (D), the statistical premises for this claim collapse under scrutiny.

### **B. Repetition of the myth**

The persistence of this myth is understandable. Abortion providers and advocates have long repeated the mantra that abortion (at least early abortion) is safer than childbirth. *See, e.g.*, “Safety of Abortion,” National Abortion Federation (NAF) (2006), <https://tinyurl.com/NAFAbSafety> (“Complications from having a first trimester aspiration abortion are considerably less frequent and less serious than those associated with giving birth”).<sup>8</sup> Planned Parenthood also has a post claiming that “abortion is . . . 11 times safer than giving birth,” *see* “Is abortion safe?” *Planned Parenthood*, <https://tinyurl.com/PPAbSafeTeens>. *See also* “Medical and Social Health Benefits Since Abortion

Was Made Legal in the U.S.,” *Planned Parenthood*, <https://tinyurl.com/PPAbSafe> (“the risk of death associated with childbirth is about 14 times as high as that associated with abortion”). The National Academies of Sciences (NAS) most recently has taken up the same mantle, see NAS “The Safety and Quality of Abortion Care in the United States” at 74-75 (2018).<sup>9</sup> The

The point of the phrase “abortion care” is presumably to soften the impact of the stark word “abortion” by adding the appealing word “care.” Nevertheless, the phrase “abortion care” is awkward and, from the perspective of abortion proponents, redundant. A surgeon does a heart bypass, not “heart bypass care.” A technician does a mammogram, not “mammogram care”. And an abortionist does abortions, not “abortion care.” See also *ProMedica Health* (continued...)

challengers in *Whole Woman's Health* made the same assertion. Their complaint repeatedly asserted that abortion was safer than childbirth. No. 15-274, Cplt. ¶¶ 80, 105, 130 (No. 15-274, JA 148, 154, 160). The *WWH* complaint went so far as to assert that the risk of maternal death was 14 times higher in childbirth than abortion. *Id.* This allegation related to *WWH*'s claim that when abortion becomes unavailable, risk to maternal health increases.

### **C. Refutation of the myth and possible backpedaling**

Amicus ACLJ filed a brief in *Whole Woman's Health* that thoroughly refuted the claim that abortion is safer than childbirth. *See* Amicus Brief of American Center for Law & Justice *et al.*, *Whole Woman's Health v. Hellerstedt*, No. 15-274 (Feb. 2, 2016) (ACLJ *WWH* brief), <https://tinyurl.com/WWH-ACLJ-Amicus>.

Perhaps for reasons similar to those set forth in that ACLJ amicus brief, major abortion advocacy groups may be quietly backing off the claim that abortion is safer than childbirth. For example, Planned Parenthood recently removed a similar claim from its website. *Compare* "In-Clinic Abortion Procedures," *Planned Parenthood*, <https://tinyurl.com/PP-Apr-2016> (Apr. 21, 2016 version; click on "How Safe Are In-Clinic Abortion Procedures?": "the risk of death from childbirth is 11

times greater than the risk of death from an abortion procedure during the first 20 weeks of pregnancy”) *with* “How safe is an in-clinic abortion?” *Planned Parenthood*, <https://tinyurl.com/PPcurrent> (no longer making that claim).<sup>10</sup> NAF, meanwhile, has not updated its similar assertion in over a decade, *supra* note 8.

#### D. Dissecting the myth

The abandonment of the claim that abortion is safer than childbirth would be a strategically wise choice for abortion advocates, as the claim lacks defensible support – in short, it is a myth resting on inapposite and incomplete data.

The faulty claim rests essentially upon a comparison of pregnancy mortality (formerly called “maternal mortality”) and abortion mortality statistics published by the federal Centers for Disease Control and Prevention (CDC). *See, e.g.*, Elizabeth G. Raymond & David A. Grimes, *The comparative safety of legal induced abortion and childbirth in the United States*, 119 *Obstet. Gynec.* 215, 215-16 (2012), <https://tinyurl.com/Raymond-Grimes>.<sup>11</sup> *But see* Priscilla Coleman, “A Serious Misrepresentation of the Relative Safety of

As demonstrated below, the claim that abortion is safer than childbirth *at all*, much less by an order of magnitude, is unsupported and almost certainly incorrect. *See, e.g.*, Byron Calhoun, *Systematic Review: The maternal mortality myth in the context of legalized abortion*, 80 *The Linacre Q.* 264 (2013), <https://tinyurl.com/BCalhounSysRev>. This Court therefore should not assume that access to abortion provides a life- or health-saving benefit to pregnant women.

While the *Roe* Court treated the relative safety of (early) abortion over childbirth as “now-established medical fact,” 410 U.S. at 163, this “fact” – properly recharacterized thereafter by the *Akron* Court as a “factual assumption,” 462 U.S. at 430 n.12 – is no such thing. First, the unthinking comparison of pregnancy mortality and abortion mortality statistics is *not* probative because there are crucial differences in the derivation of these statistics. It is a comparison of apples and oranges. Second, the medical literature strongly, arguably overwhelmingly, indicates that abortion is *poor* health care for women, particular as compared to the alternative of childbirth, *infra* § III.

Key points about the flawed basis for the abortion-is-safer claim include the following:

First, **abortion deaths are also counted as “pregnancy deaths,” thereby misleadingly inflating the measure of deaths supposedly from childbirth.**<sup>12</sup> This point bears emphasis: when a woman dies from abortion, that death counts *both* as an abortion mortality *and* as a pregnancy mortality. With such an approach, the results are mathematically stacked against childbirth ever being deemed safer than abortion: *even if every single woman in a single year who had an abortion died from the procedure, and only one woman that year died from a miscarriage or complication of childbirth, the total number of deaths in the “pregnancy mortality” category for that year would*

*still be higher than the total deaths in the “abortion mortality” category.*

This makes comparison of the two figures positively absurd. The abortion mortality rate – “legal induced abortion-related deaths per 100,000 reported legal abortions,” CDC, “Abortion Surveillance – United States, 2016” <https://tinyurl.com/CDCAbortionSurveillance>, will *inevitably* be lower than the pregnancy mortality rate, regardless of actual relative lethality, except where the denominator for the abortion statistic – the number of procedures – is so low as to counterbalance the inherent slanting of the comparison. That is, only where the number of abortions is relatively small, as with later-term procedures, will the abortion mortality rate figure have a chance of exceeding the pregnancy mortality rate figure.

Second, **pregnancy mortality is measured per childbirth, not per pregnancy,<sup>13</sup> and thus is further artificially inflated.** That is, the relevant maternal population arbitrarily excludes those who experience miscarriages and stillbirths, except that *if such women die, their deaths are nevertheless included in the maternal mortality totals.* Thus, the relevant baseline population is reduced by excluding cases of pregnancy losses (no live birth), yet the total number of deaths still includes those maternal deaths resulting from these very same excluded – uncounted – pregnancies.

For example, even though many women survive ectopic pregnancies, the supposed pregnancy mortality rate for the subset of all ectopic pregnancies will be infinitely high. There will be some maternal deaths in the numerator but *no live births* in the denominator, yielding an infinitely large fraction. Obviously, this is a completely misleading, useless, statistic. But this same error will in turn infect and distort the overall pregnancy mortality rate by adding to the numerator (deaths) while not adding to the baseline denominator (live births). This is no trivial distortion: historically, ectopic pregnancies have been the leading cause of deaths in the first trimester. See “Current Trends Ectopic Pregnancy – United States,” 1990-92, *CDC Morbidity & Mortality Wkly. Rep.: Surveillance Summaries*, Jan. 27, 1995, at 46, [www.cdc.gov/mmwr/preview/mmwrhtml/00035709.htm](http://www.cdc.gov/mmwr/preview/mmwrhtml/00035709.htm).

The same distortion flows from the inclusion of deaths from early miscarriages, while excluding the number of associated pregnancies from the baseline. As with ectopic pregnancies – or any other pregnancy mishap that produces no live birth (including, ironically, abortions) – this combination of statistical parameters misleadingly inflates the reported percentage risk of childbirth (in mathematical terms, the numerator [maternal deaths] is maximized, while the denominator [not all pregnancies, only live births] of the risk fraction is arbitrarily reduced). Hence, the pregnancy mortality figure, contrary to its title, does *not* accurately depict

the mortality risk of pregnancy. Instead, the statistic *overstates* the risk.<sup>14</sup>

Third, **the overall pregnancy mortality figures do not account for the stage of gestation.** A high percentage of maternal deaths are associated with miscarriages early in pregnancy; but obviously, for example, a woman entering her second trimester faces zero risk of a first-trimester death from ectopic pregnancy, yet the undifferentiated pregnancy mortality rate incorporates those first-trimester deaths. For a woman who is beyond any given stage of pregnancy and considering the relative risks of continued pregnancy versus abortion, it makes no sense to compare abortion mortality with pregnancy mortality *throughout* pregnancy; the figures would have to be adjusted to subtract out deaths occurring at stages of pregnancy that have already passed.<sup>15</sup> Yet pregnancy mortality statistics do not make this adjustment and thus are not properly comparable to abortion mortality statistics.

Fourth, **abortion deaths are underreported.** One simply cannot make a fair assessment of abortion deaths without knowing how many there were. Yet one published study found that, in Finland, *an astounding 94% of abortion-associated deaths were not identified*

from death certificates or cause-of-death registries alone. Mika Gissler, *et al.*, “Methods for identifying pregnancy-related deaths: population-based data from Finland 1987-2000,” 18 *Paediatric & Perinatal Epidemiology* 448, 451 & tbl. 2 (2004). Aggravating the problem of unidentified abortion deaths in this country is the fact that “the collection and reporting of abortion data are not federally mandated,” CDC, “Abortion Surveillance – United States, 2016,” *supra* p. 19 (“Description of the Surveillance System”). *See also* David C. Reardon, *et al.*, “Deaths Associated with Abortion Compared with Childbirth – A Review of New and Old Data and the Medical and Legal Implications,” 20 *J. Contemp. Health Law & Pol’y* 279, 286-91 (2004) (hereinafter Reardon, “Deaths Associated with Abortion”); *id.* at 289-90 (noting that official coding standards impede the reporting of abortion deaths); David C. Reardon, “The Cover-Up: Why U.S. Abortion Mortality Statistics Are Meaningless,” 8 *The Post-Abortion Review* (Apr.-June 2000) (recounting numerous instances where independent investigators found, or other sources revealed, far more abortion deaths than the CDC reported); “The CDC’s Abortion Death Numbers, and What They Mean,” *RealChoice* (Aug. 8, 2012), <https://tinyurl.com/RealChoiceCDCAbDthCount> (illustrating incompleteness of CDC abortion mortality numbers across multiple years); “The CDC Report and Abortion Deaths,” *ClinicQuotes* (Aug. 29, 2012), <https://clinicquotes.com/the-cdc-report-and-abortion-deaths/> (documenting specific instance of well-publicized abortion death that CDC failed to report).

Fifth, **abortion mortality statistics likely will not include many delayed deaths that result from abortion**,<sup>16</sup> deaths such as those reflected in the increased rates of suicide or other longer-term fatal post-abortion health consequences, even though studies show a greater risk of death from these and other causes after abortion (as opposed to childbirth). *Infra* § III. A fair comparison of abortion with continued child-bearing, like a fair comparison of smoking with nonsmoking, would have to take into account not just immediate consequences, but also all other statistically significant increased death risks.

#### **E. Response to contrary statements in *Whole Woman's Health* & District Court findings**

In light of the foregoing, the contrary statements in this Court's majority in *Whole Woman's Health v. Hellerstedt* (*WWH*), and the findings of the district court in the present case, are easily addressed.

In *WWH*, this Court referred to material in the record asserting that “[n]ationwide, childbirth is 14 times more likely than abortion to result in death,” 136 S. Ct. at 2315 (citing that case's Joint Appendix at 272).

The district court in the present case, meanwhile, made the following finding:

There is far more risk associated with carrying a pregnancy to term and delivering a baby than with abortion. (Doc. 190 at 129:22-130:5, 199:6-10; JX 123 ¶ 61; Doc. 195 at 32:4-10.)

Pet. App. 209a (finding No. 205). But the record references do not provide any solid support of the proposition that abortion is safer than childbirth. JX 123 is the petitioners' expert report of Dr. Christopher Estes. Dr. Estes states at ¶ 61 (Rec. p. 2459) that some women who do not have access to abortion "instead, carry unwanted pregnancies to term," and that these women "are exposed to increased risks of major complications from childbirth, including death," but he provides no supporting citation. Dr. Estes does indicate (¶ 67, Rec. pp. 2460-61) that he relied in part on CDC abortion surveillance reports. As discussed *supra* § II(D), such reports provide no valid basis for concluding that childbirth is safer than abortion. Beyond that, the citation to Doc. 190 at 129-30 (JA 218-19) is to trial testimony of petitioners' witness Dr. Doe No. 3, who ventures a somewhat hedged opinion in response to a question about his "own experience" and offers no

supporting reference.<sup>17</sup> Doc. 190 at 199 (JA 288) is trial testimony of Dr. Estes, who simply repeats, without reference, the assertion that abortion is safer than childbirth. Doc. 195 at 32 (JA 1051) is the testimony of petitioners' witness Prof. Eva Pressman, who simply repeats the assertion without any supporting reference. In short, aside from adding "me too" affirmations, the record references identify no substantive support for the proposition that abortion is safer than childbirth.

\* \* \*

As demonstrated, the seemingly straightforward comparison of the CDC's pregnancy mortality and abortion mortality rates is in fact fundamentally misguided and rife with flaws. As the CDC itself has admitted, the statistics for pregnancy mortality and abortion mortality are "conceptually different" and "used by CDC for different public health purposes," Letter of Louise Gerberding, Director, Centers for

Thorp, Jr., “Public Health Impact of Legal Termination of Pregnancy in the US: 40 Years Later,” 2012 *Scientifica* 1, 4 (“Differences in ascertainment of deaths, duration of susceptibility to mortality, lack of accounting for gestational age, and choice of appropriate comparison group make these comparisons a fool’s errand”). For purposes of comparison they are apples and oranges.

There is strong evidence that abortion is positively detrimental to maternal health and, if anything, more likely to lead to death or other adverse consequences than is continuing the pregnancy. *See infra* § III. Access to abortion is no favor to women’s health.

### **III. PUBLISHED LITERATURE INDICATES THAT, IF ANYTHING, ABORTION IS *MORE* DANGEROUS THAN CONTINUED PREGNANCY.**

Peer reviewed medical research strongly indicates that abortion, rather than being safer than childbirth, is in fact more dangerous.

In Finland, for example, researchers drew upon national health care data to examine the pregnancy history of *all* women of childbearing age who died, for any reason, within one year of childbirth, abortion, or miscarriage, between 1987 and 1994 (a total of nearly 10,000 women). The study found that, adjusting for age, *women who had abortions were 3.5 times more likely to die within a year* than women who carried to term. Mika Gissler, *et al.*, “Pregnancy-associated deaths in Finland



1987-1994 – definition problems and benefits of record linkage,” 76 *Acta Obstetrica et Gynecologica Scandinavica* 651 (1997). See also E. Karalis, *et al.*, “Decreasing mortality during pregnancy and for a year after while mortality after termination of pregnancy remains high: a population-based register study of pregnancy-associated deaths in Finland 2001-2012,” 124 *BJOG* 1115 (2017); *id.* at 1117 (“In all age groups under 40, mortality rates were highest after termination of pregnancy”); *id.* at 1119 (“Combining all causes of deaths, the mortality rate after termination of pregnancy is . . . alarming”).

A study based upon Medicaid records in California likewise found significantly higher mortality rates after abortion. The study linked abortion and childbirth records in 1989 with death certificates for the years 1989-97. This study found that, adjusting for age, *women who had an abortion were 62% more likely to die from any cause than women who gave birth.* David C. Reardon, *et al.*, “Deaths associated with pregnancy outcome: A record linkage study of low income women,” 95 *So. Med. J.* 834 (2002).

Yet another study, this one of nearly a half million Danish women, found that the risk of death after abortion was significantly higher than the risk of death after childbirth. David C. Reardon & Priscilla K. Coleman, “Short and long term mortality rates associated with first pregnancy outcome: Population register based study for Denmark 1980-2004,” 18 *Med. Sci. Mon.* 71 (2012). The study specifically examined both early (before 12 weeks gestation) and late (after 12 weeks gestation) abortions, and found statistically

significantly higher death rates for *both* groups as compared to mortality after childbirth. Another study of the entire population of Denmark found a *dose effect* – that is, each additional abortion increased the risk of premature death of the woman: “Increased risks of death were 45%, 114% and 191% for 1, 2 and 3 abortions, respectively, compared with no abortions after controlling for other reproductive outcomes and last pregnancy age” Priscilla K. Coleman *et al.*, “Reproductive history patterns and long-term mortality rates: a Danish, population-based record linkage study,” 23 *Eur. J. Pub. Health* 569, 569 (2012).

In fact, a systematic literature review has shown that *every record linkage study* examining mortality rates after abortion and childbirth *has found an elevated risk of death associated with abortion*. David C. Reardon & John M. Thorp, “Pregnancy associated death in record linkage studies relative to delivery, termination of pregnancy, and natural losses: A systematic review with a narrative synthesis and meta-analysis,” *SAGE Open Med.* (Nov 13, 2017), <https://tinyurl.com/RecordLinkageReview>. At least part of this increased risk of death is due to psychological effects, such as suicide. The Finland and California studies both showed, *inter alia*, a heightened risk of suicide after abortion.<sup>18</sup> (The Danish study did not examine this aspect.) A British study found the same thing. Christopher L. Morgan, *et al.*, “Mental health

may deteriorate as a direct effect of induced abortion,” 314 *British Med. J.* 902 (Mar. 22, 1997) (letters section) (suicide attempts more than four times as frequent after abortion than after childbirth). All these studies are consistent with the many studies documenting adverse emotional consequences after abortion. See David C. Reardon, “Abortion Decisions and the Duty to Screen: Clinical, Ethical and Legal Implications of Predictive Risk Factors of Post-Abortion Maladjustment,” 20 *J. Contemp. Health L. & Pol’y* 33, 39 n.14 (2003) (citing nearly three dozen sources).

A related consequence of abortion is the elevated risk of substance abuse. See, e.g., David C. Reardon & Phillip G. Ney, “Abortion and Subsequent Substance Abuse,” 26 *Am. J. Drug & Alcohol Abuse* 61 (2000); David C. Reardon, *et al.*, “Substance use associated with unintended pregnancy outcomes in the National Longitudinal Survey of Youth,” 26 *Am. J. Drug & Alcohol Abuse* 369 (2004); Priscilla K. Coleman, *et al.*, “Substance use among pregnant women in the context of previous reproductive loss and desire for current pregnancy,” 10 *British J. Health Psychol.* 255 (2005).

Other psychological effects associated with abortion may also contribute to a decline in health. Notably, there is a clear scientific consensus that *abortion contributes to mental health problems* in some women. The only controversy is when, if ever, abortion is the *sole* cause of specific mental illnesses in specific groups of women at higher risk. David C. Reardon, “The abortion and mental health controversy: A comprehensive literature review of common ground agreements, disagreements, actionable recommenda-

tions, and research opportunities,” *SAGE Open Med.* (Oct 29 2018), <https://tinyurl.com/RevAbMentalHlth>.

Of course, abortion can also cause physical harm, either from the procedure itself (e.g., perforation of the uterus, laceration of the cervix), from deprivation of the health benefits of continuing pregnancy (e.g., eliminating the protective effect of a full-term pregnancy against breast cancer),<sup>19</sup> or by masking other dangerous symptoms (e.g., a woman with an infection or an ectopic pregnancy may believe her symptoms are merely normal after-effects of abortion, leading her to delay seeking medical help).<sup>20</sup> *See generally* “Physical effects of abortion: Fact sheets, news, articles, links to published studies and more,” *The UnChoice*, [www.theunchoice.com/physical.htm](http://www.theunchoice.com/physical.htm) (listing sequelae and referencing sources); Reardon, “Deaths Associated with Abortion,” *supra* p. 22, at 311-17 (same).

\* \* \*

Just as “time has overtaken some of *Roe*’s factual assumptions,” *Planned Parenthood v. Casey*, 505 U.S. at 860, so *evidence* has overtaken the assumptions and assertions of *Roe*, and of abortion apologists, about the safety of abortion. There is now ample reason to believe that abortion is *detrimental* to maternal health and, if

anything, *more likely* to lead to death or other adverse consequences for the pregnant woman than is continuing the pregnancy.

Abortion is a procedure fraught with hazards. The notion that abortion is safer than childbirth rests on inapposite comparisons and incomplete data, flies in the face of far more rigorous peer-reviewed studies, and should not be relied upon by this Court for any purposes.

### CONCLUSION

This Court should affirm the judgment of the Fifth Circuit.

Re: Abortion statistics and maternal health

Dear Secretary Thompson:

In the challenges to the federal partial birth abortion statute, as on many other occasions, the proponents of legalized abortion make the claim that abortion is safer for women than childbirth. There is very good reason to believe that this claim is false. However, a fair scientific examination of this claim is hindered by the way the Centers for Disease Control (CDC) maintains its relative maternal mortality statistics.

I am writing to urge your office to direct a reassessment of the pertinent statistical measures. In

short, the HHS should see to it that the American public -- and in particular, women contemplating the choice between abortion and continuing pregnancy -- have a genuine basis for an honest and meaningful comparison of the relative risks. If, in the alternative, the CDC is unable to provide a basis for a true comparison, it should so state.

The CDC has in the past reported maternal mortality as the “[n]umber of maternal deaths per 100,000 live births.” See, e.g., [www.cdc.gov/epo/mmwr/preview/mmwrhtml/00054602.htm](http://www.cdc.gov/epo/mmwr/preview/mmwrhtml/00054602.htm) (Fig. 1, footnote \*) (Maternal Mortality -- United States, 1982-1996). Abortion mortality, by contrast, is reported as the number of “[l]egal induced abortion-related deaths per 100,000 reported legal induced abortions.” See, e.g., [www.cdc.gov/mmwr/preview/mmwrhtml/ss5212a1.htm](http://www.cdc.gov/mmwr/preview/mmwrhtml/ss5212a1.htm) (Table 19, footnote \*) (Abortion Surveillance -- United States, 2000).

Here are some of the concerns with these statistics:

1. Denominator too small for maternal mortality rate

Maternal mortality should reflect deaths per pregnancy, not deaths per live birth. Stillbirths and miscarriages are fairly common occurrences.<sup>1</sup> To count

maternal deaths associated with miscarriages, for example, while not counting the pregnancies, improperly inflates the maternal mortality rate.<sup>2</sup>

2. No maternal mortality rate adjustment for gestational stage

The relative risk of aborting versus continuing a pregnancy should reflect the prospective risks only, and not risks associated with stages of pregnancy already passed. For example, ectopic pregnancies cause a significant percentage of maternal deaths, and indeed are the leading cause of deaths in the first trimester. See, e.g., [www.cdc.gov/mmwr/preview/mmwrhtml/00035709.htm](http://www.cdc.gov/mmwr/preview/mmwrhtml/00035709.htm) (Current Trends: Ectopic Pregnancy -- United States, 1990-92). Obviously, a woman entering her second trimester faces zero risk of a first-trimester death from ectopic pregnancy, yet the undifferentiated CDC maternal mortality rate incorporates those first-trimester deaths. An abortion cannot eliminate risks that have already passed; only prospective risks should enter into the comparison.

3. Underreporting of abortion-related deaths

deaths," i.e., "16 percent [ended] in a miscarriage or stillbirth").

<sup>2</sup> Of course, live births should be counted only once for each labor, regardless of whether the woman bears at one time a single child, twins, triplets, or a greater number.

A true statistical comparison of the risks of death from abortion versus continued pregnancy is impossible if the statistics are inaccurate. Thus, the apparently common failure to report abortion-related deaths see [www.afterabortion.org/PAR/V8/n2/abortion-deaths.html](http://www.afterabortion.org/PAR/V8/n2/abortion-deaths.html) (“The Cover-Up: Why U.S. Abortion Mortality Statistics Are Meaningless”), underestimates the abortion mortality rate. The same problem would apply to any underreporting of other maternal deaths. (And, of course, abortion-related deaths must be excluded from the maternal mortality rate if any comparison is to be made. Counting abortion deaths as maternal deaths as well -- or instead -- stacks the deck against childbearing and in favor of abortion.)

#### 4. Disregard of non-immediate deaths

Recent studies indicate that abortion is associated with an increased rate of short-term and long-term maternal death. See [www.afterabortion.org/physical.html](http://www.afterabortion.org/physical.html) (“A list of Major Physical Sequelae Related to Abortion”). A fair comparison of abortion with continued childbearing, like a fair comparison of smoking with nonsmoking, would take into account all such statistically significant increased death risks.

\* \* \*

Women choose or decline abortions for many different reasons, and the decision for many may represent a complex balance of multiple considerations. It is a grave disservice to withhold from

women the information needed for a genuine comparison between abortion mortality and the risk of mortality from continuing the pregnancy. Such information may be decisive for many women. Moreover, abortion businesses, which have profit motives for women to choose abortion, cannot be relied upon to present the full picture. Indeed, such businesses may be using statistics -- despite the flaws described above -- to help sell abortion to trusting lay women. Cf. [www.abortion.com/questions.html](http://www.abortion.com/questions.html) (claiming that “statistically, childbirth is far more dangerous than abortion”).

I strongly urge you to direct the CDC to make all necessary adjustments to its preparation and presentation of statistical data to allow for an honest, unbiased comparison of the relative risks of abortion and continuing pregnancy.

Dear Mr. Weber:

We appreciate your interest in the Centers for Disease Control and Prevention's (CDC) efforts to collect and publish maternal mortality statistics (including those related to abortion). CDC makes every effort to identify all such deaths and to present maternal mortality statistics using established scientific methods.

The maternal mortality rate is computed as all maternal deaths per 100,000 live births. In contrast, the measure used for abortions is a case-fatality rate which is computed per 100,000 legal abortions. These measures are conceptually different and are used by CDC for different public health purposes.

CDC calculates the maternal mortality rate per 100,000 live births for the following reasons:

1. To maintain comparability in long term trends for the United States. Estimates of the number of pregnancies (including live births, miscarriages or stillbirths, and induced abortions) in the United States have been published only since the 1970s.
2. The live birth component of the pregnancy estimates is highly reliable. Virtually all births are counted in every year. Estimates of all abortions are based on CDC's abortion surveillance system, which relies on state abortion reporting systems. Estimates of stillbirths, ectopic pregnancies, and miscarriages are based on survey data and are subject to significant sampling error, particularly for smaller population subgroups. Estimates of stillbirths and miscarriages are based on pregnancy history data from the National Survey of Family Growth (NSFG). The NSFG is conducted periodically, every 5 to 7 years. The data are subject to sampling error, particularly for smaller population subgroups. For information on the estimation methodology, see [www.cdc.gov/nchs/data/series/sr\\_21/sr21\\_056.pdf](http://www.cdc.gov/nchs/data/series/sr_21/sr21_056.pdf).
3. To maintain international comparability. Many other countries cannot adequately estimate the number of pregnancies,

especially those in which abortion is illegal. Information on miscarriage and stillbirth also varies considerably in completeness. In the interest of international comparability, the World Health Organization has specified that the number of live births should be used for the denominator of the maternal mortality rate.

Adjusting the maternal mortality rate for gestational stage is not statistically feasible, because this requires data that are not currently completely available. The Pregnancy Mortality Surveillance System (PMSS) relies primarily on death certificates which do not typically provide this information. Gestational age may be available for some maternal deaths in cases where linkage with other records (e.g., birth certificates, fetal death reports) is possible. Information on gestational age for induced abortions is available in about 42 states or jurisdictions.

CDC recognizes that despite efforts to count all maternal deaths (including those abortion-related) in the United States, some remain uncounted. The death itself is reported but accurate information on the cause may not be provided. CDC estimates that maternal deaths in general are underreported by 30 to 150 percent (see [www.cdc.gov/mmwr/preview/mmwrhtml/ss5202e1.htm](http://www.cdc.gov/mmwr/preview/mmwrhtml/ss5202e1.htm)). The nature of the surveillance systems make it difficult to obtain complete data. The PMSS compiles data from 50 states, the District of Columbia, and New York City. Abortion surveillance involves

data from 47 states, District of Columbia, and New York City. These systems are voluntary (CDC does not provide remuneration for data) and rely primarily on death certificate data which may or may not provide information that indicates the death was maternal or abortion-related. In the case of deaths associated with induced abortion, CDC also uses searches of computerized print media databases (Lexis-Nexis) to identify additional cases.

At CDC we are very committed to improving data collection systems and providing the most accurate and reliable data on all aspects of maternal and infant health. I hope this information is helpful.
